Physicians will be able to begin submitting requests to TurningPoint for Prior Authorization for these additional procedures beginning on **03/01/2026** for dates of service on or after **04/01/2026**. While it is the responsibility of the rendering physician to obtain prior authorization, facility providers are encouraged to contact TurningPoint to verify the prior authorization has been complete for Health Plan members prior to admission.
